Structured Settlements

A structured settlement is a method of paying damages to a plaintiff (injured party) over a period of time when a lawsuit is settled. Structured settlements usually result from personal injury cases, specifically cases that involve:

- Product liability
- Motor vehicle collisions
- Wrongful death
- Medical malpractice

In those cases, the parties involved often agree to have damages paid over a period of years rather than with one lump sum. The damages are usually funded in the form of an **annuity contract** issued by an insurance company.
